Proposed Projects:

I. Update Airport Master Plan

This project is the sponsor share of a completed Airport Improvement Program (AIP) project to update the Airport's Master Plan. The previous plan was over ten years old and did not reflect the airport's current situation and future plans.

II. Rehabilitate Apron

This project is the sponsor share of a completed AIP project. This project on the Portland Cement Concrete terminal apron was replacement of slabs with multiple cracks, and repair of spalls, cracks, and joints on other slabs.

III. Construct Rehabilitate Runway 12/30 (Maintenance)

This project is the sponsor share of a completed AIP project. The asphalt concrete runway was highly oxidized and loosing bituminous binder and fine aggregates. A fog seal with new markings extended the runway life.

IV. Construct Access Road

This project is the sponsor share of a completed AIP project. The project provided new access to the airport terminal, airport fire station, and a new fuel farm. The project also included reconstruction of the airport terminal parking lot and construction of a new fuel farm.

V. Rehabilitate Runway 12/30

The project is the sponsor share of a completed AIP project. The project was an asphalt concrete overlay of the runway. The rehabilitation was necessary to correct surface deterioration, and cracking caused by environmental damage.

VI. Acquire Snow Removal Equipment

This project is the sponsor share of a Wyoming Department of Transportation, Aeronautics Division project to purchase two 22' wide plow blades. The first blade was a ramp blade which allows the snow plow operator to push snow to the edge of the apron for blowing, or removal. The second blade replaced a blade on an existing plow truck that had exceeded its useful life.
